Admission Circular (Non DAE)

Date: 09/09/2020

Admissions are open for candidates under **Non-DAE category**, who have completed class 10th either in CBSE, MS Board or any equivalent boards. Atomic Energy Junior College offers vocational course in Electronics, Electrical Maintenance and Computer science alongwith other main subjects. The usual science stream may be opted for Information technology/Languages (Hindi/Marathi). Commerce stream is also offered. The admission is based on the guidelines issued by MS Board. Students, passing through CBSE/ICSE/NIOS are expected to submit migration certificate.

Eligibility Norms

- i. Admissions are offered subject to the vacancy in the stream applied for,
- ii. The criterion for admission are based on the norms framed by the Department of Education, Govt. of Maharashtra and adopted by the Governing Council of Atomic Energy Education Society from time to time,
- iii. Admission to the Candidates from other Boards/States to FYJC in AEJC is purely provisional subject to the eligibility of the applicant from M.S.Board, Mumbai,
- iv. Marks Criteria :
 - a. For Science and Vocational (on Merit Basis) Minimum pass marks in AISS/SSC Examination in 35% in Science.
 - b. For Commerce Minimum pass marks is 35% in AISS/SSC Examination.
 - c. Admissions for Science, Vocational and Commerce course of FYJC (Std. XI) will be strictly on merit and will be restricted to the number of seats that would be available.
 - d. Candidates seeking admission must have passed the qualifying examination in **ONE ATTEMPT** only.

Note:

- i. Those students who opt for Vocational Group must clearly indicate the vocational subject of their **First, Second and Third Preference**. If they don't indicate their **Second and Third Preference**, it will be considered that they do not want any other Vocational subject. If they do not get the subject opted for, against **First Preference**, they will be automatically considered for the **Science Group with Biology**.
- ii. If order of preference of stream is not given, the candidates will be considered only with the option given by him/her. If no option is given, the candidate will be considered for commerce stream only.

Instruction for online Application Form:

1. **Read Instructions before filling up the Application Form, All entries in the online Form are mandatory,**
2. **Keep scanned copy of following document for the upload along with the application form - (i) Class X Mark Sheet, (ii) Transfer Certificate, (iii) Caste Certificate (if applicable) (iv) Parents Signature, (v) Photo of the Student**
3. **More than one application form will not be accepted, only the first Application will be treated as valid application for Admission,**
4. **Make all entries with accuracy, Mismatch of information in online application form and document may lead to rejection of application or cancellation of admission if the same is noticed at later stage,**
5. **Incomplete Application will be rejected,**
6. **Print entire filled-in Application Form after final submission of the online form, which will be available on your email,**
7. **The above filled-in Form along with the copy of document/s has to be submitted to AEJC at the time of verification.**

IMPORATANT NOTE:

Documents to be submitted in the College Office for confirmation of admission in FYJC (2020-21) :

- 1) **Printout of submitted online admission application form**, available in email of the applicant,
- 2) Employer Certificate of the parent, if any (original),
- 3) SSC Mark list (Attested copy) of the applicant- original for verification,
- 4) Transfer / School Leaving Certificate – Original, **not to be returned after admission,**
- 5) **Migration Certificate in case of candidate has passed from other board,**
- 6) Aadhar Card (Xerox copy) of the applicant mandatory for address verification,
- 7) Proof of Govt. Accommodation (if applicable)/ Address proof –(Xerox copy Duly signed by parent),

- 8) Caste Certificate (if applicable) – Attested copy
- 9) Undertakings as per the enclosed proforma (Original).
- 10) One photograph with border (4.5 X 3.5 cms) to be pasted on the Admission Form.

Instructions to the students regarding admission

1. Detailed **eligibility criteria for the admission in class XI under MS Board** is available on line at AEJC website under admission portal,
2. Class X passed with **Basic Maths** students are eligible **only** for **Commerce Stream**,
3. Exercise all the six options as per your choice given in on line process. Later no claim will be entertained for change of choice.
4. Fee structure and amount to be paid is available (www.aees.gov.in).
5. Submission of (class X) TC (in original) along with the original fee receipt paid through online in college is mandatory for confirmation of admission. Fee payment through on line alone does not confirm admission. If the conformed admission is cancelled due to any reason, the Old T.C (class X) will not be issued, instead college will issue new T.C and the claim of fee refund will be as per AEES REFUND rules,
6. **No claim of old TC will be entertained, if the admission is cancelled.**

Eligibility Certificate

Candidates, who have passed Class X Exam from the other board other than Maharashtra Board and are seeking admission in AEJC, are required to submit ORIGINAL Provisional Eligibility Form duly completed along with the required enclosures viz.

- a. Copies of (TC/SLC) duly countersigned by appropriate authority in relevant cases,
- b. First Attempt Certificate,
- c. Mark sheet of Class X,
- d. Original Migration Certificate from the board,
- e. Deed of undertaking on the stamp paper at appropriate time as given by the Office.
- f. Passing Certificate should be submitted immediately after receiving from the board.

The Maharashtra State Board of Secondary and Higher Secondary Education issues a Provisional Eligibility Certificate after receiving the above mentioned documents. It will be obligatory on the part of the students to collect the passing certificate and Migration certificate from the School/Jr.College, on receipt of the same from CBSE/ICSE or other state boards and submit the same to the Maharashtra State Board of Secondary and Higher Secondary Education, Vashi, Navi Mumbai, to get the Final Eligibility Certificate. The Eligibility Certificate should be submitted in the College office on or before the last working day of December positively failing which they will not be entitled to appear for the final exams. If they are permitted to take the exams, their results will not be declared and they will not be promoted to SYJC without the final EC as per the rules of the Board.
