Admissions are open for bonafide DAE Employees' wards who have passed class 10th either from CBSE, MS Board, or any equivalent boards. AEJC offers admission to the Science and Commerce streams. Students passing through CBSE/ICSE/NIOS must submit a migration certificate.

Eligibility Norms

- i. Admissions are open only to the wards of the employees of the Department of Atomic Energy.
- 11. The criteria for admission are based on the norms framed by the Department of Education, Government of Maharashtra, and adopted by the Governing Council of Atomic Energy Education Society from time to time.
- iii. Admission to the Candidates from other Boards/States to FYJC in AEJC is purely provisional, subject to the approved Eligibility* of the applicant from the M.S. Board, Mumbai.
- iv. Candidates must have passed in five subjects with English as one of the subjects in AISSE/SSC.
- v. The reservation policy is as per the M.S. Board rules.
- vi. Marks and Subject Criteria:
 - a. For Science (on Merit Basis):- Minimum pass marks in AISS/SSC Examination
 - b. For Commerce (on Merit Basis):- Minimum pass marks in AISS/SSC Examination
 - c. Admission for Science & Commerce course of FYJC (Std. XI) will be strictly on merit and will be restricted to the number of seats available.

Vocational subjects have two papers (Paper-I & Paper-11 for each subject)

*Eligibility Certificate(after the admission)

Candidates who have passed Class X Exam from other boards, i.e., other than Maharashtra State Board, and are seeking admission in FYJC at AEJC, Mumbai, are required to submit an ORIGINAL filled-in application form for Eligibility Certificate through AEJC along with the required enclosures viz.

- a. Copies of (TC/SLC) duly countersigned by an appropriate authority in relevant cases as per rules,
- b. Photocopy of original Mark sheet of Class X(Digilocker certificates are not accepted by the MS board)
- C. Original Migration Certificate from the board,
- d. Deed of undertaking (enclosed in the Eligibility form) as per updated norms of the Board.
- e. Copy of Marks Statement and Passing Certificate should be submitted immediately after receiving from the board**.

The Maharashtra State Board of Secondary and Higher Secondary Education issues a Provisional **Eligibility Certificate** after receiving the above-mentioned documents.

It will be obligatory on the part of the students to collect the passing certificate and Migration certificate from the respective School/Jr. College, on receipt of the same from CBSE/ICSE or other state boards, and submit the same to AEJC, Mumbai, in time for submission to Maharashtra State Board of Secondary and Higher Secondary Education, Vashi, Navi Mumbai, to get the Final Eligibility Certificate. Without a Final Eligibility Certificate, students will not be entitled to appear for the final exams. If they are permitted to take the exams, their results will not be declared, and they will not be promoted to SYJC (Class XII) without the final Eligibility Certificate as per Board rules. Please note that the MS board imposes a fine on late submission of the Eligibility form and required documents as per the rules laid down by the MS board from time to time.

Note:

Students who opt for the Vocational Group must clearly indicate the vocational subject of their First, Second, and Third Preferences. If they don't indicate their Second and Third Preference, it will be considered that they do not want any other Vocational subject. If they do not get the subject opted for, against First Preference, they will be automatically considered for the other streams where vacancies exist.

Please note: NO change in subjects will be allowed after the admission process is complete.

Instructions to the students regarding admission

- I. Exercise all the options as per your choice given in the Google form. Later, **no claim** will be entertained for a change of choice.
- After the display of the Merit List, a candidate who is offered his/her combination of subjects must pay the fees (online) for the stream/combination offered. Otherwise his/her name will be struck off from the admission process, and no claim will be entertained in this regard thereafter.
- After the display of merit list and payment of fees, the candidate may be offered his preferential
 choice, subject to the vacancy in each combination of the subjects. The difference of fees, if any,
 should be paid immediately.
- 4. The fee structure and amount to be paid are available in the Admission Circular (www.aees.gov.in). Misc. Fees are displayed on the AEJC website (www.aeicmumbai.ac.in).
- 5. Submission of (class X) Original TC along with the original fee receipt paid through online in college is mandatory for confirmation of admission. Fee payment through online alone does not confirm admission. If the confirmed admission is canceled for any reason, the Old T.C (class X) will not be issued; instead college will issue a new T.C, and the claim for fee refund will be given as per AEES Refund rules.
- 6. No claim of old TC will be entertained if the admission is cancelled.

Documents to be submitted to the College Office for confirmation of admission in FYJC (2025-26):

- 1. Online fee payment receipt Original
- 2. Two recent passport-size photos of the student
- 3. Self-attested photocopy of Class X Mark sheet
- 4. Transfer/ School Leaving Certificate Original, not to be returned after admission
- 5. Proof of Govt. Accommodation (if applicable)/ Address proof-(Photocopy)
- 6. Aadhar Card (Photocopy) of the applicant
- 7. Students coming from other State Boards should submit TC/SLC duly countersigned by Education Department authorities of the State or as per update on Rules.
- 8. Self-attested photocopy of the **caste certificate** in case of SC/STNJ/NT/SBC & OBC communities **in the name of the students** issued by the Executive Magistrate / Tahsildar and revalidated in Maharashtra, if from another state.
- 9. Self-attested photocopy of Birth Certificate if the place of birth is not indicated in TC/SLC.
- 10. Self-attested photocopies of Certificates of NCC, Scout, and Intermediate drawing exam, participation in Sports and cultural activities at state/national level, and selection in INMO.
- 11. Employment certificate of either parent serving in DAE units (Original).
- 12. Undertakings on Fee collection as per the enclosed/prescribed proforma (Original).
- 13. A copy of a bona fide certificate and a first attempt certificate
- 14. A copy of the CHSS card of the student
